BUSINESS COUNCILS

The Business Councils are the **core** of our Chamber's activities. They are composed of members of our National Chambers and bring **experts** from business sectors to discuss **policy, regulation, and market access** and **engage with the Government** and other relevant stakeholders. The Business Councils research and study European-related **business, trade and investment** topics relevant to Hong Kong and Macau and the rest of the Greater Bay Area and **facilitate networking**.



Wine & Spirit Business Council (WSBC)

WSBC focuses on imported wine and spirits issues, including tax, regulations, IP and responsible consumption.



European Automotive Council (EAC)

EAC focuses on a safer, greener, more efficient and more competitive automotive sector.



Intellectual & Property Rights Business Council (IPRBC)

IPRBC focuses on policy, regulatory, and market access issues in the field of IPR and wider trade-related matters.



European Council for Sustainable Development (ECSD)

ECSD focuses on a wide range of sustainability issues such as the energy transition and the circular economy.

European Sourcing & Trading Council (ESTC)

ESTC focuses on sourcing and trading issues emerging around HK-Mainland synergies, talent development and regulatory incentives.



European Travel & Tourism Council (ETTC)

ETTC focuses on strengthening and facilitating travel & tourism for European companies and their workforce, as well as enabling the recovery journey of the sector after the pandemic.



WORKING GROUPS

The working groups are an extension of the Chamber's business councils, and similarly **engage experts** from various business sectors in discussions with **Hong Kong authorities** regarding the relevant **policies and regulations**.



Sustainable Finance Working Group


The Sustainable Finance Working Group focuses on the fostering of the ESG talent pool in Hong Kong, supporting work on a global approach to taxonomies, and increasing the standards for disclosure and ESG reporting.
